#### I. COMPANY PROFILE

The Brahmaputra Valley Fertilizer Corporation Limited (BVFCL) was incorporated in 2002 under the Indian Companies Act 1956 with the objective to de-merge the Namrup I, II and III plants from Hindustan Fertilizer Corporation Ltd. It is one of the enterprises engaged in the production of Urea fertilizer. BVFCL is a CPSE in fertilizer sector with the administrative jurisdiction of Department of Fertilizers, Ministry of Chemical and Fertilizers. The company employed 499 regular employees (Executives-369 & Non-Executives- 130) as on 31.03.2021.

Its Registered and Corporate offices are at Namrup, Assam.

The authorised share and paid up capital of the Company was Rs. 510 crore and Rs.365.83 crore respectively as on March 31, 2021.

The shareholding of the Government of India in the Company is 100%.

#### **II. JOB DESCRIPTION AND RESPONSIBILITIES**

Director (Production) is a member of Board of Directors and reports to Chairman and Managing Director. He/ she acts as the head of the Production/ Operations Division of the Company. His/ her principal responsibility is to exercise control for the efficient operations of the plants of the Company in a manner which would ensure optimum utilization of resources. He/ she also acts as Principal Adviser of the Company in all production and operational matters.

#### **III. ELIGIBILITY**

## 2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – in one of the followings:-

(c) State Public Sector Enterprise (SPSE) where the annual turnover is \*Rs 750 crore or more;

### 3. QUALIFICATION:

The applicant should be an Engineering graduate with good academic record from a recognized University/ Institution.

Applicants holding MBA/ Post Graduate Diploma in management will have an added advantage.

## 4. EXPERIENCE:

The applicant should possess adequate technical/ operational experience at a senior level in a large organization of repute, out of which at least five years during the last ten years should have been in major production units in Fertilizers/ Chemicals/ petrochemicals sector.

## **IV. DURATION OF APPOINTMENT**

**2.** Applicants from Private Sector must submit the following documents along with the application form:

(b) Whether the company is listed or not; if yes, the documentary proof (please provide URL or attach/enclose copies);

(c) Evidence of working at Board level or at least a post of the level immediately below the Board level;

(d) Self-attested copies of documents in support of age and qualifications;

# VI. UNDERTAKING BY THE APPLICANT

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

# 3. For candidates from SPSE/ Private Sector

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

4. In the above cases, no request for relaxation or otherwise would be entertained.
