

General Guidelines for Document Verification

1. For document verification candidates shall bring all certificates in original to prove your credentials mentioned in the application which includes the following:-
 - a. HSLC certificate (with DOB mentioned in the certificate)/ Proof of date of Birth as per School Leaving Certificate.
 - b. All other educational certificates in original.
 - c. Certificates in proof of relevant experience detailed in the notification. Those who are presently working shall submit reasonable proof of employment in the relevant field to the satisfaction of the Management, without which such experience will not be counted.
 - d. Caste/Category Certificate (if applicable) issued by the Competent Authority (SDM/Tahsildar & above) applicable to Central Government Establishments. EWS candidates shall submit EWS certificate of relevant year (income 2021-22) as per Central Government guidelines. OBC candidates shall submit self declaration along with OBC-NCL certificate and if engaged shall submit OBC-NCL certificate issued by Competent Authority. Candidates belonging to SC/ST Community should submit self attested copies of their valid caste/tribe certificates in the Prescribed format issued by the Competent Authority.
 - e. Original photo ID (such as Passport/Voter Card/Driving License / PAN Card/ Aadaar Card).
 - f. Any other relevant certificates / documents.
2. Please note that if you are not able to produce any of the aforesaid documents at the time of verification of documents to the satisfaction of BVFCL Management, your claim to that extent will not be considered and eligibility will be determined accordingly.
3. If at any stage of the recruitment process or after the appointment it is found that any information furnished by you is incorrect/false or you do not meet the eligibility criteria pertaining to age, qualification, community, PwBD, relevant experience etc. Your candidature is liable to be cancelled.
4. NO TA/DA will be paid for appearing for Document Verification and Skill /Proficiency Test.
5. The candidate found medically unfit will be considered disqualification.
